

Submission on the proposed Turtle Street Beach Resort - *Environment Protection and Biodiversity Conservation Act 1999 Act (EPBC Act) Referral - Letters of Support*

This submission on the proposed Turtle Street Beach Resort EPBC Act referral is made on behalf of the project proponent, QRE Pty Ltd, to submit letters of support received from key Government and community organisations on the proposed project.

I refer to the current approval that the Turtle Street project is seeking under *the Environment Protection and Biodiversity Conservation Act 1999*.

One of the five national investment priorities of the Australian Trade and Investment Commission (Austrade) is investment into tourism infrastructure, to support increased supply of accommodation under the Government's long-term strategy for tourism, Tourism 2020. For a number of years the Australian Government has been working to attract foreign investment into Australia to increase the quantity and quality of our tourism offerings in order to grow the national visitor economy. We are concerned, in particular, at how best to attract investment into regional areas both to encourage visitor dispersal and assist in the development of regional economies and employment.

Part of the remit of Austrade is to provide the Tourism Major Project Facilitation (TMPF) service. 
